### **Spain** - 21DCES02 "Strategy for BIM implementation in public procurement in Spain"

#### **Description & outcomes**

- Strategy (adopted 06/2023) and action plan for BIM implementation in public procurement in Spain.
- Series of BIM training workshops including introductory training at high level across all Ministries and technical training to ES authorities.
- 25 October 2023: 1<sup>st</sup> high level EU BIM Public Officials Group met in Madrid with DG REFORM & TSI projects participation.



### **Greece** - 23EL36 "Implementation of the BIM Roadmap in Greece, including pilot projects"

21EL78 "Deployment of a Strategic Plan and Roadmap for the Implementation of Building Information Modelling (BIM) in Greece"

#### **Description & outcomes**

- o Official adoption by the Greek government of the first National BIM Strategy and Roadmap
- Selection and initiation of BIM pilot public procurement projects.
- Capacity building on project-specific contractual and procurement documentation.
- Communication strategy for sharing BIM-related efforts with the private sector.
- Raising awareness and capacity building among construction sector stakeholders in preparation for BIM implementation.



**Poland** - 21DCPL03 "Boosting competitiveness of railway sector to increase the competitiveness of green mobility and reach solid socio-economic convergence"

#### **Description & outcomes**

- Analysis of the state of play of the railway sector in Poland, especially the implementation of the BIM methodology, and gather of information on good practices and lessons learned for the railroad construction sector.
- Market research on BIM contracts based on integrated project team approach and define contract templates and procurement clauses for the implementation of that approach.
- Extensive video training material.
